ENTRIES:

- a) \$25.00 per dressage class. \$2.00 Number Deposit, \$20.00 per jumping round, \$10 per additional round of the same level. \$10.00 fee charged for entries taken after the closing date.
- b) Make checks payable to "Bit O Woods Farm"
- c) Negative Coggins required within 12 months
- d) No refunds after closing date.
- e) Please return bridle numbers when competition is over. The number deposit is refunded upon receipt of number at the secretary's stand.
- f) There is a \$20.00 schooling fee for any horse not competing coming to school on the property during the show. Negative Coggins also required.

AWARDS: Six ribbons awarded each dressage class. (Classes will be divided if entries warrant.) Clear round ribbons presented for original jumping test.

OTHER INFORMATION: All dressage classes will be held in a stone-dust outdoor arena. Small arena for horse trials Test through Training Level 1 & 2. Large arena for Training Level 3 and above. Jumping to take place on grass. Management reserves the right to cancel/combine classes as necessary. A waiting list will be established if oversubscribed. Hard hats must be worn at all times while mounted. Food will be on the grounds. **SORRY NO DOGS ALLOWED**

DIRECTIONS:

From Route 295: Exit at Route 38 East Mt. Holly and follow Route 38 for several miles and refer to directions immediately below.

From Route 38E: After the traffic light at Prospector's turn right at the next light onto Masonville-Fostertown Rd. Proceed straight and through blinking traffic light. Continue straight about 1/8 mile and turn left into Bit 'O' Woods Farm.

From Route 38 W: Take jughandle marked Creek Rd (Wolfington Bus Co. landmark.) At end of ramp turn left and cross over Route 38 (Wawa on right). At blinking traffic light turn left onto Fostertown Rd. Continue straight about 1/8 mile and turn left into Bit 'O' Woods Farm.

From Route 70: Turn onto Route 541N. (Medford-Mt. Holly Rd.) toward Lumberton/Mt. Holly. Go straight crossing over Church Rd at Wawa. At next intersection turn left onto Fostertown Rd. Continue straight about 1½ miles. After Phillips Rd, Bit O Woods Farm entrance on the right.
