- a) \$25.00 per dressage class. \$2.00 Number Deposit, \$20.00 per jumping round, \$10 per additional round of the same level. \$20.00 late fee charged for any incomplete entries and/or any entries received after the closing date. This policy will be strictly enforced.
- b) Make checks payable to "Bit O Woods Farm"
- c) Negative Coggins required within 12 months
- d) No refunds after closing date.
- e) <u>Please</u> return bridle numbers when competition is over. The number deposit is refunded upon receipt of number at the secretary's stand.
- f) There is a \$20.00 schooling fee for any horse not competing coming to school on the property during the show. Negative Coggins also required.

<u>AWARDS</u>: Six ribbons awarded each dressage class. (Classes will be divided if entries warrant.) Clear round ribbons presented for original jumping test.

OTHER INFORMATION: Dressage classes will be held in an indoor small arena. Jumping to take place in a stone-dust outdoor arena. Management reserves the right to cancel/combine classes as necessary. A waiting list will be established if oversubscribed. Hard hats must be worn at all times while mounted. Please make sure to bring your own food and beverage. **SORRY NO DOGS ALLOWED**
