ENTRIES:

- a) \$25.00 per dressage class, \$20.00 per jumping round, \$10 per additional round of the same level, Any changes or missing items (including entry fee payment) after the closing date will incur a \$15 fee. A \$20.00 late fee will also be charged for entries taken after the closing date.
- b) Office fee \$10
- c) Make checks payable to "Bit O Woods Farm"
- d) Negative Coggins required within 12 months
- e) No refunds after closing date.
- f) There is a \$20.00 schooling fee for any horse not competing coming to school on the property during the show. Negative Coggins also required.

AWARDS: Six ribbons awarded each dressage class. (Classes will be divided if entries warrant.) Clear round ribbons presented for original jumping test.

<u>OTHER INFORMATION:</u> All dressage classes will be held in a stone-dust outdoor arena. <u>Small arena for horse trials tests only</u>. Jumping to take place on grass. Management reserves the right to cancel/combine classes as necessary. A waiting list will be established if oversubscribed. Hard hats must be worn at all times while mounted. **SORRY NO DOGS ALLOWED**
